bler recommended Bob Meader from the Columbus Police Department. Vice-president Weyand made a motion to book Enter for the first day and Butler for the second day. This motion was second by many and approved by all.

Secretary Zampelli suggested going to lanyards for the 2018 convention. He showed the Board various width sizes. Treasurer Powers suggested going with the one inch width and Secretary Zampelli will have a draft made up and a quote on 300 of the lanyards.

Trustee Gillespie suggested that he buy supplies for the hospitaliltiy room beforehand instead of waiting the night before. The Board agreed.
