- III. Secretary's Report: Secretary Zampelli read the minutes from the May 20, 2016 Board Meeting. Trustee Kuebler made a motion to accept the minutes, second by Treasurer Powers and approved by all.

 New Business: The Board discussed gifts for the conference. Secretary Zampelli passed around catalogues containing numerous giveaway items. No decision was made but the Board will continue looking at the options.
